# At a glance – terms used in this document

Term Used	Explanation
FOISA	Freedom of Information (Scotland) Act 2002  Places a duty on those organisations covered to proactively publish certain types of information; and to respond to requests for information; and to provide advice and assistance to those making requests for information.
EIRs	Environmental Information Regulations (Scotland) 2004  Those organisations covered by EIRs have a duty to respond to requests for environmental information.
SIC	The Scottish Information Commissioner  Who is responsible for ensuring that those bodies covered by FOISA and EIRs comply with the terms of the legislation.
MPS	Model Publication Scheme  Produced by the SIC – this details all of the information that those subject to FOISA should publish (if they hold it).
Guide to Information	A guide that all organisations subject to FOISA and adopting the MPS must produce to help people access the information it makes available.
Classes of Information	Nine broad categories describing the types of information authorities should publish (if they hold it).

#### Background

The Freedom of Information (Scotland) Act 2002 (FOISA) requires that all housing associations / co-operatives in Scotland must produce and maintain a publication scheme. This must detail all of the key information that we publish and how you can access it. This Guide to Information is our publication scheme, and contains links to where you can find all of the information listed online.

Yoker Housing Association Limited has adopted the Scottish Information Commissioner's (SIC) <u>Model Publication</u> Scheme (MPS), and this guide has been approved by the SIC.

The purpose of this Guide to Information is to:

- Allow the public to see what information is available for Yoker Housing Association Limited in relation to each class in the Model Publication Scheme;
- State what charges may be applied;
- Explain how to find information easily;
- Provide contact details for enquiries and to get help with access to information; and
- Explain how to request information that has not been published.

#### **The Model Publication Scheme Principles**

The MPS imposes the following six principles which govern the way we must make our information available through our Guide to Information:

- Principle 1: Availability and formats
- Principle 2: Exempt information
- Principle 3: Copyright and re-use
- Principle 4: Charges
- Principle 5: Advice and assistance
- Principle 6: Duration

#### Principle 1 - Availability and Formats

All of the information listed is available on our website (unless stated), and completely free to access online. However, we understand that not everyone will have online access and where this is the case you can contact us to view this in our office (where this would be convenient).

If you would like a printed copy of any of the information listed, we may have to charge a small fee to provide this. This fee will never exceed the cost of photocopying and postage – and we will let you know any total cost before we forward this to you.

#### **Principle 2 - Exempt Information**

Whilst we will try to make all of the information we have detailed available, in rare cases there may be some information that we cannot make available. For example, sometimes if we were to publish certain Management Committee minutes, it could reveal personal details about an individual. This would be a breach of Data Protection legislation if we were to do so. When this is the case, we will remove any personal details before publication and highlight where and why we have done so.

#### Principle 3 - Copyright and Re-use

Where we hold the copyright on our published information, the information may be copied or reproduced without formal permission, provided that:

- It is copied or reproduced accurately;
- · It is not used in a misleading context and
- The source of the material is identified.

Where Yoker Housing Association Limited does not hold copyright in information we publish, we will make this clear.

#### Principle 4 - Charges

This section explains when we may make a charge for our publications and how any charge will be calculated. There is no charge to view information on our website or at our premises.

We may charge for providing information to you, but we will charge no more than it costs us to do so. We will always tell you what the cost is before providing the information to you.

Our charges for providing any information detailed in this guide are summarised below:

View at our office	Free
Print in black and white	10p per A4 sheet
Print in colour	20p per A4 sheet
Optical Media (e.g. CD / DVD)	50p per Disc
Posted document (including CD / DVD)	Cost of postage incurred (Royal Mail First Class)

#### Charges for information that is not available under the scheme

If you submit a request to us for information which is not available in the Guide the charges will be based on the following calculations:

#### General information requests

- There will be no charge for information request which cost us £100.00 or less to process.
- Where information costs between £100.00 and £600.00 to provide you may be asked to pay 10% of the cost. That is, if you were to ask for information that costs us £600.00 to provide, you will be asked to pay £50.00 calculated on the basis of a waiver for the first £100.00 and 10% of the remaining £500.00.
- We are not obliged to respond to requests which will cost us over £600.00 to process.
- In calculating any fee, staff time will be calculated at actual cost per staff member hourly salary rate to a maximum of £15.00 per person per hour.
- We do not charge for the time to determine whether we hold the information requested, nor for the time it takes to decide whether the information can be released. Charges may be made for locating, retrieving and providing you information. In the event that we decide to impose a charge we will issue you with notification of the charge (i.e. a fees notice) and how it has been calculated. You will have three months from the date of issue of the fees notice in which to decide whether to pay the charge. The information will be provided to you on payment of the charge. If you decide not to proceed with the request there will be no charge to you.

Charges for Environmental Information that is provided under the EIRs rather than FOISA.

The rules for charging for environmental information are slightly different.

We do not charge for the time to determine whether we hold the environmental information requested or deciding whether the information can be released. Charges may be made for locating, retrieving and providing information to you (e.g. photocopying and postage). If we decide to impose a charge, we will issue you with notification of the charge and how it has been calculated. The information will be provided to you on payment of the charge. If you decide not to proceed with the request there will be no charge to you. Charges will be based on the following calculations:

- Photocopying is charged at 10p per A4 sheet for black and white copying, 20p per A4 sheet for colour copying.
- Postage is charged at actual rate for Royal Mail First Class.
- Staff time is calculated at actual cost per staff member hourly salary rate to a maximum of £15.00 per person per hour.

The first £100.00 worth of information will be provided to you without charge.

Where information costs between £100.00 and £600.00 to provide, you will be asked to pay 10% of the cost. That is, if you were to ask for information that cost us £600.00 to provide, you would be asked to pay £50.00, calculated on the basis of a waiver for the first £100.00 and 10% of the remaining £500.00.

Where it would cost more than £600 to provide the information to you, however, we will ask you to pay the full cost of providing the information, with no waiver for any portion of the cost.

Charges for requesting for your own personal data

There is no charge for requesting your own personal data under the General Data Protection Regulation (GDPR) Subject Access Request. We must provide a copy of the information free of charge.
